

## ARTICLES OF INCORPORATION

NORTHEAST COMANCHE TRIBE OF 10 1427 09-16-92

THE UNDERSIGNED, DESIRING TO FORM A CORPORATION UNDERSTHE 1 20.00 LAWS OF THE SPATE OF KANSAS, ADOPT THE FORESWING ALL 20.00 ARTICLES OF INCORPORATION. THIS SHALL BE A NON-PROPIT CORPORATION.

### ARTICLE I

THE NAME OF THE CORPORATION SHALL BE THE NORTHEAST COMANCHE TRIBE, INC.

### ARTICLE II

THE PRINCIPAL PLACE OF BUSINESS OF THE CORPORATION SHALL BE 117 Gunsmoke, DODGE CITY, KS. 67801.

## ARTICLE III

THE PURPOSE OF THIS NON-PROFIT CORPORATION SHALL BE THE TRANSACTION OF ANY AND ALL LAWFUL BUSINESS FOR WHICH CORPORATION MAY BE INCORPORATED UNDER THE LAWS OF THE STATE OF KANSAS

THE INITIAL BUSINESS OF THE CORPORATION SHALL BE TO CONDUCT AVIATION ORIENTED EDUCATIONAL CHARITABLE AND/OR SCIENTIFIC ACTIVITIES AND TO PROMOTE GOOD MAINTENANCE OF, FLIGHT SAFETY IN AND THE FLYING ENJOYMENT OF PIPER COMANCHE AIRCRAFT AND TO FURTHER & SPIRIT OF COMRADESHIP AMONGST MEMBERS OF THE INTERNATIONAL COMANCHE SOCIETY THROUGH AVIATION ORIENTED SOCIAL ACTIVITIES OF ITS MEMBERS.

# ARTICLE IV

THE FISCAL YBAR OF THE CORPORATION SHALL BE JANUARY 1 THROUGH DECEMBER 31 OF EACH YEAR.

# ARTICLE V

THE NUMBER OF PURSONS TO SERVE ON THE BOARD OF DIRECTORS SHALL BE NOT LESS THAN THREE OR THAT GREATER NUMBER FIXED FROM TIME TO TIME BY THE BY LAWS OF THE CORPORATION. THE FOLLOWING PERSONS SHALL CONSTITUTE THE INITIAL BOARD OF DIRECTORS, TO SERVE UNTIL THEIR SUCCESSORS ARE ELECTED AND QUALIFIED.
