Comanches at Newport, NH on June 15th

Nine Comanches flew in to Parlin Field in Newport, NH on the Saturday of Father's Day weekend. This day turned out to be the one really nice one in a string of rainy days in June. Aircraft arrived from all the New England states except Maine, as well as Pennsylvania and western New York.

As usual, the folk at Parlin Field were very accommodating, and even with all the rain in the days



before, the grass parking area was firm and dry. As it turned out, the field was pretty busy that day. In addition to our ICS-NE fly-in there was a wedding being held on the banks of the Sugar River at the far end of the turf runway in the afternoon, and a 200-guests fund raising gala that evening in the large FBO

hangar. Parlin Field is owned and run by the Town of Newport, with no direct funding from state or federal budgets, and is definitely a poster child example of how to run a small GA airport.



Lunch at the Lil' Red Baron was as good as ever, with a wide choice of Mexican and Gringo menu items. Nobody had room for dessert, not even the incredible fried ice cream.

Pete Morse, fly-in host, talked about some of the features of the airport and pointed out the next few flyins on the schedule. There was a discussion about the upcoming Tribe elections. The plan was to keep the schedule as is – electronic balloting and election of officers at the Sky Manor fly-in in August – rather than try to cram everything in before the 2013 Convention in Seattle. Bernie Stumpf, current Tribe Chief, will represent the NE Tribe at the Convention Board meetings.

After lunch we all lined up for \$5.45 low-lead at the self serve pump, happily pushing and pulling each aircraft into place. The decision was unanimous that we plan a return fly-in to Parlin next year.





Fly-in at Ellenville, NY delayed one week for weather

Once again the weather gods conspired against us for our fly-in at Ellenville, NY. This time a stalled tropical depression left lousy flying weather all up and down the east coast so the original dates were scrubbed and an alternate date the following Sunday became the new plan. The weather turned out beautiful, with temperatures in the mid 80's after a week of high 90's. Four Comanches flew in, plus another couple who drove from nearby, for a total of 10 in attendance. There were others who could not attend because of prior commitments.

Nantucket Island weekend planned in September

Join us on the Grey Lady for September 13-15!

ICS-NE is hosting a 3-day fly-in weekend on Nantucket Island from Friday, Sept 13, to Sunday, Sept 15, 2013. September is the lovely end of the season time on Nantucket and most shops will still be open. There will be a number of planned activities as well as free time to explore the shops and sights. At this late date there may be only a couple of rooms left, so contact the hotel quickly.

We will fly in to Nantucket Airport (KACK) and will be staying at the <u>Nantucket Inn</u>, located just across the street. Our room block has expired but talk to the reservation desk. You may want to consider the option of flying in to join us for the day.

Flying your Comanche to Nantucket (ACK) is encouraged, but VFR only pilots should be aware of the unique local weather patterns. After all, the airport location was chosen to train Navy pilots in handling low visibility operations. The <u>Nantucket airport</u> web site has lots of helpful information for arrivals and departures. Alternative travel is by <u>Cape Air</u> from Hyannis or by the ferry from Woods Hole.



Planed activities include Saturday dinner at <u>AK Diamonds</u>. Other activities could include dinner at <u>Arno's</u> on Main Street, a guided island tour, a group visit to the <u>Nantucket Whaling Museum</u>, and plenty of free time to stroll and shop in town. The Inn provides a free shuttle to town each hour, and there are public bus routes that cover the island.

Technical Issues

Australian Horn Update - July 31, 2013, ICS Website Bruce Thumann, SW Tribe

The Australian Stabilator Horn STC has been approved by the FAA. It is also my understanding the AMOC is approved with it. All the paper work is with Alan Kerr (The Australian Engineer) now and waiting for release by him. We should be hearing something very soon now.

This is great news and we all owe a huge round of applause to our ICS friends from down under, not to mention numerous individuals from both the ICS and the CFF in the USA whose determination helped the process along.

A formal announcement will be made soon, but for now, "Be Happy", this is a one-time fix to eliminate the Stab Horn AD.

And as an ICS member, pat yourself on the back as well. It was "YOUR" ICS membership dollars that just helped to give our Comanches, even those of non-members, a breath of fresh air. And just think, the savings alone from eliminating even just one continued compliance with the current AD will likely fund your membership for the rest of your Comanche ownership days. Now go out and sign up some of those non-members whom you just saved "MANY THOUSANDS" of dollars.

The Mid-States Tribe has scheduled three weekend workshops on the required tail horn inspection. The plan is for a qualified AMT to perform the inspection on a volunteer Comanche, with the attendees helping and observing. Attendees will pay a \$25 fee, and the Comanche owner will pay \$50. The result will be AD compliance. We hope to set up a similar workshop in the Northeast, time and place to be determined. Stay tuned for further information. In the mean time a step-by-step how-to <u>description of the inspection</u> is posted on the ICS-NE website for your guidance.
