Dear Mr. Shiloh and Ms. Burrows:

I am in receipt of Mr. Shiloh's email below and find it and most of your other emails, disturbing. I have been a member of the ICS since 1978 and the Northeast Tribe the entire time. I am a former Assistant Tribe Chief and I have been an active member. At one time, I was one of the legal counsel to the Tribe Chief and I am wondering where and how did you come into possession of "bylaws" for the tribe that were never given to the members nor passed by any vote. As a matter of fact, I would like to know when and how did you change the date of voting for Tribe officers and in what capacity did you or the ICS throw members out of the society?

I have been following the legal proceedings involving you, the ICS and "the non ICS group" and I must insist that you stop misrepresenting to the members these proceedings and Court decisions. According to International Comanche Society bylaws, the only requirement to be a member is paying of money. If you want to tell the membership that Ms. Stumpf, Mr. Morse and others are not members of the ICS, maybe you should explain how you and the Board illegally terminated the membership of these paying individuals. Since you seem to be the Tribe Chief of a different organization than that of the original and legally recognized tribe, as well as that to which these non ICS individuals belong, I would like to know on what grounds and authority you think you can run someone else's company? I would also like to know with whose money are these wars being waged? I certainly did not give my permission to the ICS nor any "tribe" of which you purport to be the chief, to expend any of my membership money for these frivolous matters. This is clearly a breach of your fiduciary duty.

Let us remember, this is a voluntary organization to which we pay dues for a service, the connection between Comanche owners for the benefit of the members and their aircraft. Not an organization in which a few seem to have a financial interest, ie the ICS Board. There was a time when the organization sought group buy opportunities for the benefit of the members, including shoulder harnesses and Airworthiness Directive mitigation. Instead, a select few, you included, have lost that vision and believe that bullying and liable is the answer to your agenda. This is no longer acceptable.

As a paying member in good standing, I am requesting a copy of the full member list that used to be provided to us in the form of the "pathfinder." Additionally, I am requesting an accounting of the Comanche Flyer Foundation as well as any and all minutes of meetings of the ICS declaring the "Northeast Tribe" be accountable to and subservient to the International Comanche Society. The last time I looked, the Northeast Tribe was and is a separate corporation. We do not take orders from nor can we legally be run by another corporation.

In the meantime, may I suggest that Ms. Burrows and the rest of the board cease and desist from harassing the membership with libelous mistruths and misrepresentations in the form of these emails and perform their jobs according to the bylaws of the ICS to the benefit of the membership. Perhaps you can find the time to see if any of our advertisers would like to offer a lower rate to the organization in which they advertise for business. That has not happened and that is your job.

Remember. You serve at the pleasure of the members, not the other way around.

I eagerly await your reply. Kindly do so within 10 days of the date herein.

Dear Fellow Tribe Members.

Many of you have received an email from Pete Morse about an ongoing election. Some of our members have asked me to explain what is going on, since our tribe held an election only a few months ago.

Just for clarification, the election we held a few months ago was for our Northeast Comanche Tribe, Inc., an ICS affiliated tribe. In order to participate in that election, voters had to be a member of the ICS and our tribe. Thus, that election was recognized and sanctioned by ICS since all the officers are members of the ICS. Our tribe is an ICS Tribe, and you are all ICS members.

The notification you have received from Pete Morse and other emails on behalf of his people are for a non-ICS group that is run by CJ Stumpf, Pete Morse, Malcolm Dickinson and Ron Ward. It is not an ICS tribe. None of these people are ICS members and therefore cannot be officers of an ICS tribe.

The Bylaws of the Northeast Comanche Tribe, Inc. (which Malcolm Dickenson finally produced from the Tribe Treasurer's documents for the court case that CJ filed against the ICS) state that the tribe voted to adopt these bylaws in 1998. They also state that all members voting in our tribe election must be ICS members in good standing. In addition, all candidates standing for election must also be members of the ICS in good standing. Our current bylaws, as well as ICS bylaws, indicate the same thing.

So, please be aware of what is happening. We, the members of the Northeast Comanche Tribe which is affiliated to the ICS, already held our election this past spring. Our next election will take place in 2021. The election now being promoted by Pete Morse, is not an ICS tribe election.
